## Salida Little League Volunteer Code of Conduct

The Board of Directors of the Salida Little League has mandated the following Code of Conduct. All Managers, Coaches and Volunteers will read this Code of Conduct and sign in the space provided below, acknowledging that he or she understands and agrees to comply with the Code of Conduct.

No Board Member, Manager, Coach, Volunteer, Player or Spectator shall at any time:

1. Lay a hand upon, push, shove, strike or threaten to strike an official.
2. Be guilty of heaping personal verbal or physical abuse upon any official for any real or imaginary belief of a wrong decision or judgment.
3. Be guilty of an objectionable demonstration of dissent at an official's decision by throwing gloves, helmets, hats, bats, balls or any other forceful unsportsmanlike action.
4. Be guilty of a physical attack upon any board member, official, umpire, manager, coach, player or spectator.
5. Be guilty of using unnecessary rough tactics in the play of a game against the body of an opposing player.
6. Be guilty of the use of profane, obscene or vulgar language in any manner at any time.
7. Appear on the field of play, stands or anywhere on the Salida Little League complex while in an intoxicated state. Intoxicated will be defined as an odor or behavior issue.
8. Be guilty of gambling upon any play or outcome of any game with anyone at any time.
9. Use tobacco products while in the stands or on the playing field or in any dugout. Smoking will only be permitted in designated areas which will be at least 20 feet from any spectator stands or dugouts. No tobacco products are allowed on school facilities.
10. Be guilty of publicly discussing with spectators in a derogatory or abusive manner any play, decision or a personal opinion on any players during the game.
11. As a manager or coach, be guilty of mingling with or fraternizing with spectators during the course of the game.
12. Speak disrespectfully to any manager, coach, official or representative of the league.
13. Be guilty of tampering or manipulating any league rosters, schedules, draft positions or selections, official scorebooks, rankings, financial records or procedures.
14. Challenge an umpire's authority. The umpires shall have the authority and discretion during a game to penalize the offender according to the infraction up to and including expulsion from the game.

The Board of Directors will review all infractions of the Code of Conduct. Depending on the seriousness or frequency, the board may assess additional disciplinary action up to and including expulsion from the league.
